

GlobalSantaFe's Woolie elected 2004 Chairman

DURING IADC'S 2003 Annual Meeting in Houston 24-26 September, IADC's Board of Directors elected **Marion M Woolie** to serve as the Association's 2004 Chairman. Mr Woolie is Senior Vice President of Operations for **Global-SantaFe**. He was IADC's Vice Chairman for 2003.

The Board also elected **Edward D Kautz**, Vice President and Chief Operating Officer of **Caza Drilling**, as Vice Chairman, and **Paul A Bragg**, President & CEO of **Pride International, Inc** as Secretary-Treasurer.

Additionally, the Board elected three Divisional Vice Presidents.

IADC President **Dr Lee Hunt** and Senior Vice President **Brian T Petty** were reelected.

All terms are effective January 1, 2004.

MARION M WOOLIE

Marion M. Woolie is Senior Vice President of Operations for GlobalSantaFe Corporation. Prior to the 2001 merger of Global Marine Inc and **Santa Fe International Corp** to form GlobalSantaFe, Mr Woolie served as President of Global Marine Drilling Co.

He began his career with Global Marine in 1982 as a Senior Sales and Contracts Representative of Global Marine Drilling Co.

He was promoted to Vice President Sales, North & South America, in 1985 and to Senior Vice President-Sales & Contracts in 1997.

He was later named President of Global Marine Drilling Company, and following the merger of Global Marine and Santa Fe International he was named Senior Vice President of Operations.

Prior to joining Global Marine he worked from 1973 to 1982 for National Supply Co., where he held various posi-

tions within the wellhead/subsea and drilling equipment divisions.

An IADC Director, Mr Woolie served as 2003 Vice Chairman. He served during 2000 as the IADC Vice President-Offshore Division and sat on the association's policy-making Executive Committee during 1999-2001.

He is also a member of the American Petroleum Institute. Mr Woolie holds a bachelor's degree in management and a MBA degree in finance from the University of Houston.

EDWARD D KAUTZ

Edward D Kautz, 2003 IADC Secretary-Treasurer, is Vice President and Chief Operating Officer of CAZA Drilling Inc., a Division of **Ensign Resource Service Group Inc.**

Mr Kautz joined CAZA as Managing Director of US operations for Ensign Resource, and was named to his current position in April 2001.

He began his career in the oil and gas contract drilling industry in 1976 with **Exeter Drilling Co**, spending the next five years working in the field serving in every position from roughneck to rig manager through Exeter's engineer training program.

For the next 18 months, Mr Kautz worked as Exeter's equipment engineer, followed by an 18-month assignment as Rocky Mountain drilling manager.

In 1983, he was transferred to Oklahoma City as drilling manager, and was later promoted to division manager.

In late 1989, Mr Kautz was promoted to President of Exeter's Northern Division, based in the company's Denver headquarters. In 1991, he was promoted to President of Exeter Drilling.

Mr Kautz has been active in IADC since 1979, serving in a variety of volunteer

assignments and on the Board of Directors.

He was the 1996 Chairman of the IADC Land Division Steering Committee and served as Vice President of the IADC Land Division from 1996-98. Mr Kautz sat on the Association's Executive Committee from 1995-1997.

He graduated from Colorado State University in 1976 with a degree in mechanical engineering.

PAUL A BRAGG

Paul A Bragg, President and CEO of **Pride International, Inc**, is IADC's 2004 Secretary-Treasurer. Mr Bragg joined Pride in July 1993 as Vice President and Chief Financial Officer and was appointed the company's President and Chief Operating Officer in February 1997.

Prior to joining Pride, Mr Bragg spent more than five years structuring venture capital transactions and managing private investments.

IADC Senior Vice President-Government Affairs Brian T Petty is based in Washington with responsibilities for directing the IADC's government affairs.
